Take care guys, stay safe.

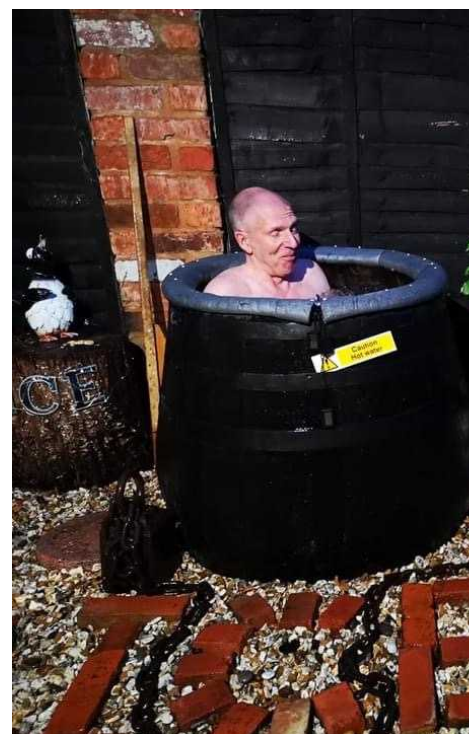

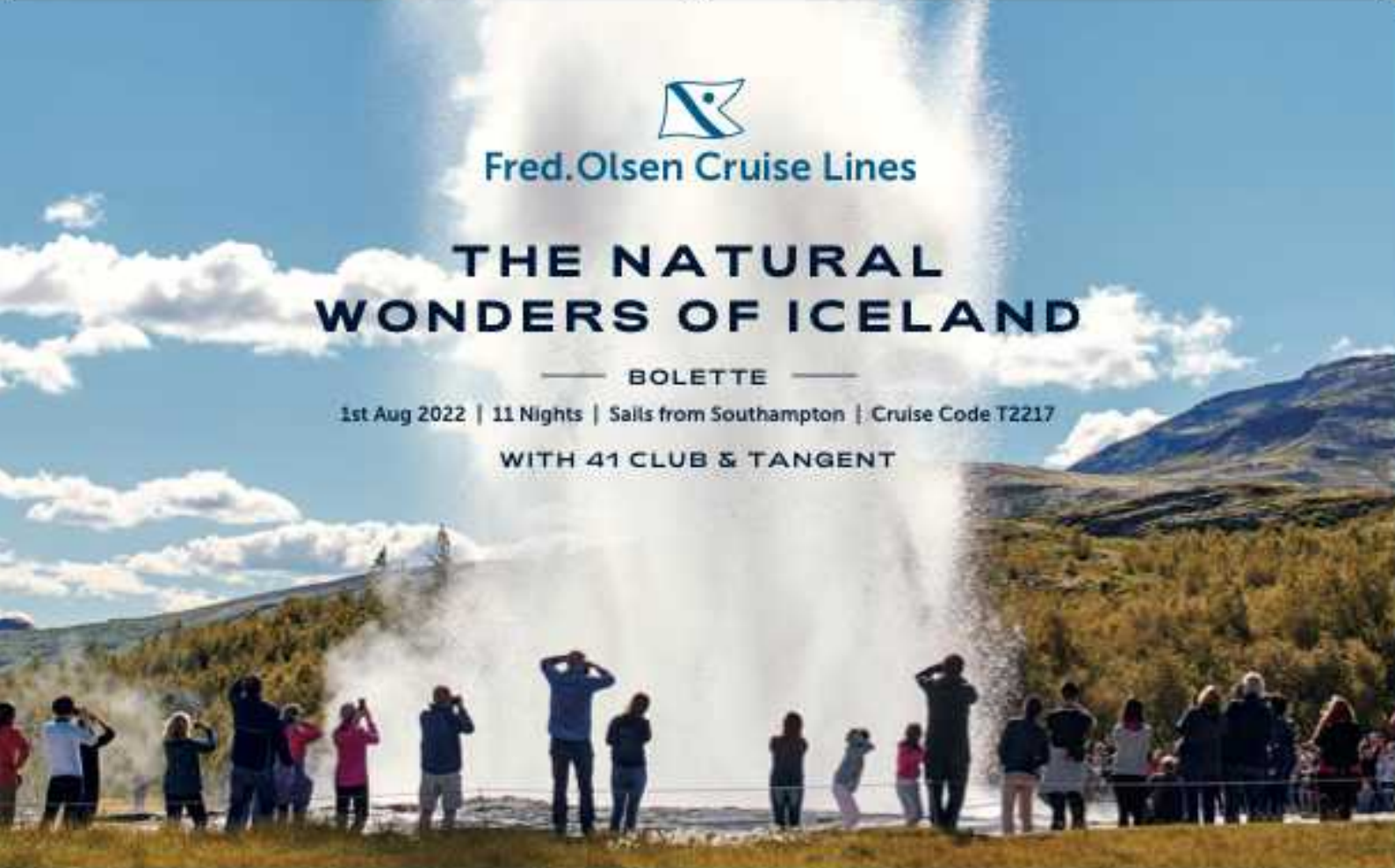



ON YER BIKE FOR DEMENTIA UK

After completing the 500 miles and 500 more walking challenge, a new 'Band of Brothers' has emerged from the Scottish mist with a new challenge. An intrepid bunch of 41ers are embarking on a virtual bike ride from Aviemore (Where conference should have been) to Nottingham (venue of the Big Weekend) in October. We are taking the most direct route, which is obviously via our next conference venue in Cardiff (somebody needs a new map).

We started on 8th May with some gruesome cycling weather. Inspiration was sought in the form of watching stage 1 of the Giro d'Italia, with the winning professional completing the route at a staggering 36.5mph. Not to be discouraged by being so comparatively slow (after all, the pro's get paid to ride that fast), we've still seen some astonishing efforts, with Steve 'Lordy' Lord currently leading the way as the virtual 'Yellow Jersey' having completed 382 miles in three weeks.

He's well past the half distance and if he had been riding the real route, he would be somewhere near Nantwich in Cheshire.

Craig Strachan is in second who was last 'sighted' just North of Lockerbie with his next town being Gretna Green - time to attend a wedding perhaps. Rounding off the podium positions is Nick Mills. Nick's position is difficult to identify as he appears to be in the middle of nowhere in Lanarkshire. I'm sure it's very nice but a landmark or two would be helpful!

Apart from benefitting from the side effects of getting fitter and maybe losing a few pounds, our aim is to raise £7060 which is £10 for every mile of the 706 mile route. It works by the team completing rides in their own locations and progress is being mapped. Hopefully the last bit can be ridden together in Nottingham in October.

'Bike Clips' is being produced each week (well, apart from last week when work just got in the way) which is our participants newsletter with progress reports and encouragement to keep riding, which at times has been likened more to an open water swim than a bike ride.

Members feedback to last month's special "How to Die Well" guide, was very positive, with one advising it was the most useful article he had ever read. One member, **Andy Nation**, of Welwyn 41 Club, advised that it was "excellent apart from the fact that it makes no mention of "Gifts out of Income" which can be a major IHT avoidance factor that is often missed by financial advisers." Accordingly, Andy kindly provided the following guide.

It is surprising that one of the most valuable exemptions from Inheritance Tax (IHT) is also one of the most underused. The normal expenditure out of income exemption applies to certain gifts. The most usual example is cash but in some circumstances the exemption can apply to chattels bought from income for the specific purpose of making the gift. The exemption is limited in amount only to the extent of a donor's (net) surplus income. When used alongside the IHT £3,000 annual exemption, it can be very useful in moving assets out of a donor's estate.

Most gifts stay in an estate for seven years after the date of gift. However, provided that a donor satisfies three conditions, gifts out of income can be treated as immediately exempt from IHT.

The qualifying conditions are: The gift must be made as part of the normal expenditure of the donor HMRC's interpretation is that the gifts should form part of a regular pattern of payments. The exemption may be available where it can be shown that the donor had made a firm commitment regarding future expenditure. You should document this intention, possibly by letter.

Examples of regular gifts could include Christmas and birthday gifts,

annual family holiday, insurance policy premiums, education costs, private healthcare arrangements, etc. The donor must retain sufficient income to maintain his (or her) standard of living.

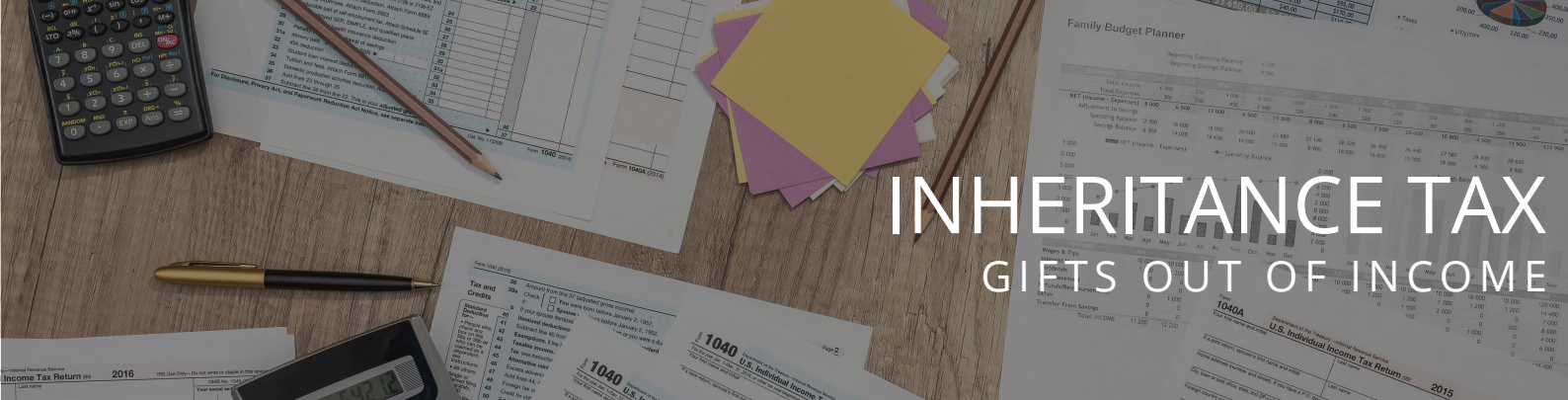
Whether or not a gift is made out of income is a subjective test. The amount of income needed, and any available surplus will vary depending upon the particular circumstances of the donor at different times. It may be helpful to prepare an income and expenditure analysis each year to clarify the position.

Gifts must be made out of income;
The exemption only applies where expenditure is from surplus net taxable income. Examples of income include salary, dividends, interest, pensions, rental income, business profits, etc. Ideally, income should be identified in the year in which gifts are made to demonstrate that there is sufficient income available, before considering earlier years. Income from earlier years does not retain its character as income indefinitely.

There are no set rules about when accumulated income becomes capital but HMRC normally considers this to happen after two years. This may be a problem where income has been accumulated.

An example of a qualifying gift Mrs Jackson had total net income (after tax) of:

	Year 1	Year2	Year3	Total
Net Income (after tax)	£120,000	£130,000	£95,000	£345,000
Regular expenditure	£75,000	£75,000	£75,000	£225,000
Surplus Income	£45,000	£55,000	£20,000	£120,000



INHERITANCE TAX

GIFTS OUT OF INCOME

Mrs Jackson wishes to gift her surplus income to her children; Bill, Ben and Alice. This would immediately remove £120,000 from Mrs Jackson's estate for IHT saving approximately £48,000, provided she can demonstrate the income has not been capitalised by Year 3.

Mrs Jackson's surplus net income fluctuates year on year, but this is not a problem.

The value of regular gifts does not have to be fixed, or even need to be made to the same donee each time.

Mrs Jackson could gift up to £40,000 per annum and still qualify for the exemption because 'taking one year with another' she has sufficient income to meet the criteria.

As with most IHT-related gifts, a donor must not retain any future benefit, either directly or indirectly, or the exemption will not be available.

Record keeping:

We would recommend that Mrs Jackson writes a letter to her chosen donee(s) to record the gift.

An example of suitable wording might be: "I have surplus income to and it is my intention to let you have a cheque for this every Christmas".

By keeping a copy of the letter this will represent contemporaneous evidence of Mrs Jackson's intentions.

It will be the responsibility of the executors to prove that the gifts meet the conditions for exemption, and submit details on schedule IHT403 to the Inheritance Tax return form IHT400. It is useful therefore if records are kept in this format during the donor's lifetime.

Summary:

As long as a donor has excess income available and can maintain appropriate records, the regular gifts out of income exemption can help to reduce IHT.

Thank you Andy. As usual with anything of a financial or legal matter 41 Club makes no recommendations and it is up to any and all members to conduct their own due diligence and to seek professional advice.

We cannot guarantee a minimum number of hours per week other than the standard 12.5 hours. The number of hours will be determined by the contracts we acquire in your area, these are provided by Nottingham CC.

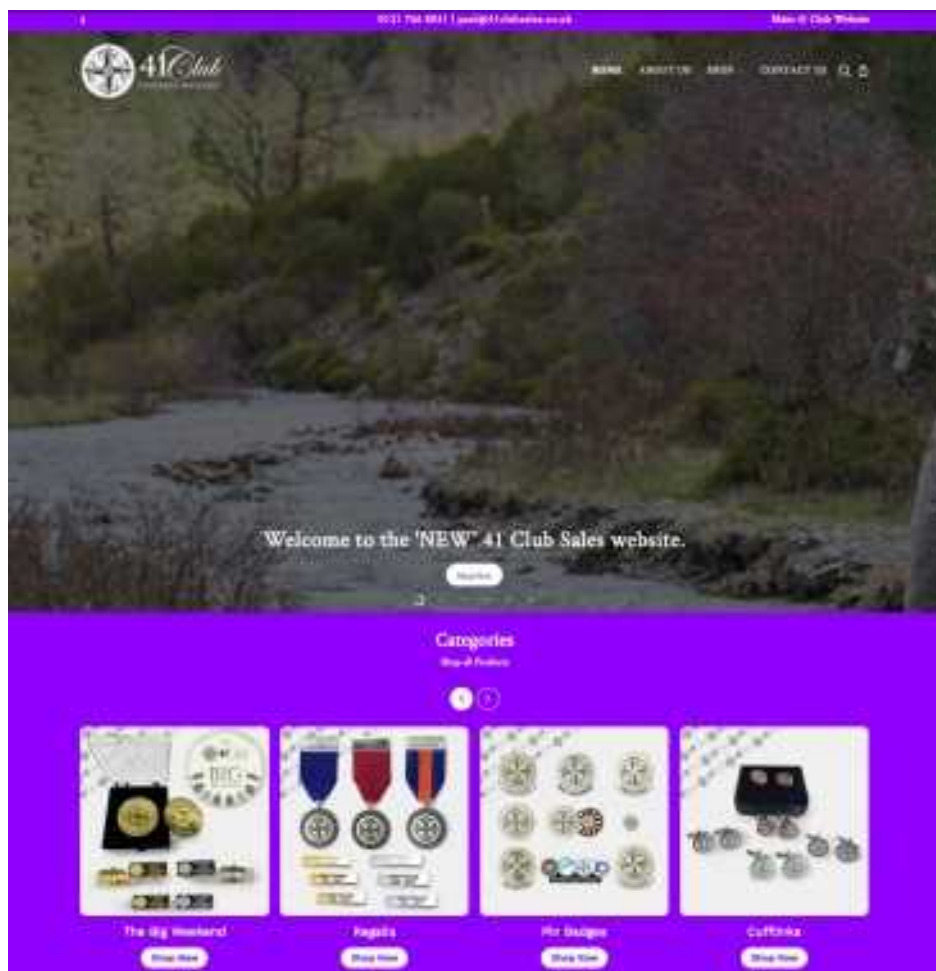

LEWIS JACKSSON, NUNEATON RT 136, BEER LEGEND

In the first instalment of a new, semi-regular guest column (which first appeared in *Tuesday Tabler*), Round Tabler and beer connoisseur Lewis Jackson shares his thoughts on two tipples that have recently tickled his tastebuds...

Hi everyone,
My name is Lewis Jackson and I am part of Nuneaton Round Table 136.

A few years ago, I started an Instagram page to review beer called The Ale Masters, which – at its peak – had around 5,000 followers. It was just for fun and gave me a good excuse to drink!

Although I had to stop posting last year, I am keen to restart my beer reviews and include a few of the write-ups in future editions of the Tuesday Tabler.

This week, I decided to select two of my recent favourites: one light beer and one dark beer. However, going forward it would be good to get input from fellow Tablers, so if there are any particular beers, breweries, styles or locations you want to see reviewed (within reason!), then please let me know.

Name: Milk Foley
Brewery: Turning Point Brew Co (England)
Style: Pale Ale
ABV: 6.3%
Purchased: Sainsbury's
Score: 9/10

This a high score for my first review, but it's absolutely deserved. It won't suit everyone's palate, but I have a preference for flavoured ales, and this very much ticked that box.

The beer has a strong strawberry jam-like flavour, which especially lingers on the aftertaste. It has a higher ABV (and you can tell!) but it's not overpowering or off-putting in any way.

Despite the clear strawberry and cream flavour, it's not overly sweet, and nor does it become sickly – it's well balanced. Overall, it's a really, really enjoyable beer. I'd been looking forward to it, and it didn't disappoint.

It would be remiss of me if I didn't mention the name, which is clearly inspired by the legendary wrestler Mick Foley (aka Mankind/Cactus Jack/Dude Love). I enjoyed it, right here at home... hopefully someone gets that!



Name: Milkshake Stout
Brewery: Rascals Brewing Company (Ireland)
Style: Stout
ABV: 4.6%
Purchased: Beer 52
Score: 8.5/10

Another high score, but this was very, very good. There were strong chocolate aromas as soon as I opened the can, which was replicated in the taste itself. The can also advertised a marshmallow and coconut flavour, both of which I noticed in the finish, which was a long one. This was great for me, as I love both of those tastes!

When served on tap, I believe that the beer is actually 5.6% ABV, whereas in can form it's 4.6%. As a result, the canned version could easily be a session beer.

Sometimes, stouts are advertised as 'flavoured', but the flavours are not always present – or only very subtly. Thankfully, that wasn't the case with this beer. Overall, it had a great combination of chocolate, marshmallow and coconut, without being too sweet. Highly recommended.
